HOPE COVE: **No Waiting At Any Time** on specified lengths of Channel View Drive Cross, Inner Hope To Outer Hope and Outer Hope Cross Roads To Lobster Pot Inn; **Keep Clear - No Stopping At Any** on a specified length of Inner Hope To Outer Hope;

IVYBRIDGE: **No Waiting At Any Time** on specified lengths of Woodland Road; **Revocation of School Entrance Clearway - No Stopping Mon-Fri 8am-4pm** on specified lengths of Woodland Road;

KINGSBRIDGE: **No Waiting At Any Time** on specified lengths of Allotment Gardens, Lower Union Road, Mill Street, The Quay and Wallingford Road; **No Loading At Any Time** on specified lengths of Ilbert Road, Prince Of Wales Road and The Quay;
