## Proposals for Summer Lane & Various Roads in Exmouth & Lympstone

Devon County Council propose to make these under the Road Traffic Regulation Act 1984 for Exmouth & Lympstone

Devon County Council (Summer Lane, Exmouth) (Traffic Regulation) Amendment Order 6169 to

- introduce Prohibition of Motor Vehicles on a specified length of Summer Lane
- revoke Weight Limit on Summer Lane

Devon County Council (Various Roads, East Devon) (40mph Speed Limit) Order 6170 to

- introduce Restricted Road (30mph Speed Limit by virtue of street lighting) on specified lengths of Dinan Way Link and Exmouth Road
- introduce 40mph on a specified length of New Link Road
- **revoke 40mph speed limit** on a specified length of Exmouth Road (to revert to restricted road (30mph by virtue of streetlighting))

## **Statement of Reasons**

As part of the Dinan Way Extension Scheme, it is proposed to introduce a 40mph speed limit on the new link road, reduce the speed along Exmouth Road to 30mph speed limit by virtue of street lighting which will include the roundabouts and prohibit motor vehicles on Summer Lane with the alternative route along the new road. Once the new link road is built, the prohibition will remove rat-running traffic between Hulham Road and Exmouth Road. The Lane will be quieter for all, and a pleasant environment for pedestrians and cyclists to use.

The purpose of the speed limits is to reduce speed allowing safer passage for all users. Vehicle access to properties and land beside the Lane will still be available, but from only one direction. It is also proposed to revoke the 7.5t Weight restriction on Summer Lane as part of this consultation.

Specifically, the restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians), for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property, and for preserving or improving the amenities of the area through which the road runs.
