

## Devon County Council (North Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

**BARNSTAPLE: No Waiting At Any Time** on specified lengths of Chaddiford Lane, Cherry Grove, Chichester Road, Higher Raleigh Road, Jordan Close, Road Past Roborough Farm House, Rumsam Road, Sowden Lane, St Georges Road, St Johns Lane and Style Close; **Limited Waiting 8am-6pm 30 Minutes No Return Within 30 Minutes** on a specified length of Raleigh Lawn; **Limited Waiting 8am-6pm 30 Minutes No Return Within 1 Hour** on a specified length of St Georges Road; **School Entrance Clearway - No Stopping At Any Time** on a specified length of St Johns Lane; **School Entrance Clearway - No Stopping Mon-Fri 8.30am-9.15am and 3pm-3.45pm** on a specified length of Westacott Road

**BRAUNTON: No Waiting At Any Time** on specified lengths of Barton Lane and East Hill

**ILFRACOMBE: No Waiting At Any Time** on a specified length of St Brannocks Park Road

**INSTOW: No Waiting At Any Time** on a specified length of Anstey Way

**LANDKEY: No Waiting At Any Time** on specified lengths of Blakes Hill Road and Newland Road

**STICKLEPATH: No Waiting At Any Time** on a specified length of Bickington Road

**SWIMBRIDGE: No Waiting At Any Time** on specified lengths of Church Lane, Hannaford Lane, Road From Bridge House To Kerscott, Sainte Honorine Du Fay Close and Station Hill

**WOOLACOMBE: No Waiting At Any Time** on a specified length of West Road

Where appropriate there will be the usual exemptions including those in relation to picking up/setting down passengers, loading/unloading goods and disabled persons vehicles

### Statement of Reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the Council and considered as part of the North Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
