## **INTRODUCE A 50MPH LIMIT on**

**A376, Exmouth Road** – southbound carriageway from a point 410 metres south of Clyst St Mary Roundabout to a point 40 metres north of Clyst St George Roundabout

**A376, Exmouth Road** – northbound carriageway from a point 40 metres north of Clyst St George Roundabout to a point 475 metres north of that roundabout

## **Statement of Reasons**

The A376 currently is National speed limit (70mph), however the infrastructure, alignment and surface quality do not meet the standard that you would expect from a road with a speed limit of 70mph and is known as a red route due to the volume of injury reported collisions, with a significant proportion of these believed to be speed related.

The proposed 50mph speed limit would be more appropriate and offer better consistency for drivers to fit in with the surrounding speed limits. Devon and Cornwall Police support the proposal of the reduction in speed, alongside a permanent speed camera site with a review to improve the signage along the route.

Specifically, the order if made will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and preserving or improving the amenities of the area through which the road runs.
